The work of the AWC and its participants spans the breadth of Water for Life is sues and is targeted towards achieving the strategies' three goals of safe, secure, drinking

Aquatic Invasive Species Team completes survey

The Council established the Aquatic Invasive Species (AIS) Project Team in June 2013 to identify gaps and opportunities for improving awareness, communication and



coordination of activities by Alberta stakeholders who are working to prevent and manage the threats of AIS.

This past winter, the team surveyed



stakeholders to develop an understanding of how AIS threats are prevented and managed in Alberta. The survey was distributed to all AWC sectors as well as other organizations and persons that have a role in water management, groups that focus on

water-based recreation, and industries not directly represented on Council. Most of the survey focused on major themes of AIS prevention and management, including:

- Risk Assessment
- Prevention Activities
- Education and Awareness
- Monitoring
- Response plans
- Stakeholder Communication

Approximately 250 responses were collected from a wide variety of individuals and organizations from across the province; all major water basins were represented as well. Among other things, early survey findings showed that:

- Lots of people are involved in AIS prevention, and even more want to be involved going forward.
- There is a lack of materials, resources and knowledge to be better engaged in AIS prevention and management.
- People and groups are ready to help, but are looking for leadership.
- Legislation needs to support effective prevention and management.

The information gathered on AIS prevention and management in the province will help the team develop its recommendations.

New project team to look at water literacy

In October 2013, the board approved a new project in the area of water literacy based on a statement of opportunity entitled "A Strategic Approach for Water Literacy; Education and Outreach in Alberta". A working group was launched to further scope the project and



develop draft terms of reference, which were approved by the board in March 2014.

The project team will propose a definition for water literacy, compile an inventory of existing programs and products for water literacy in the province, review and evaluate water literacy best practices from other juris dictions, assess water literacy levels

among Albertans, and recommend ways to improve water literacy in Alberta.

Water Literacy Webinar
